RESOLVED, that the Board of Education of the Worcester Central School District, does hereby appoint William Diamond, Superintendent, as Clerk Pro tempore, who shall perform all the duties of a clerk for the special meeting on Wednesday, August 10, 2016.

  - A. Secondary Principal Appointment  
RESOLVED, that the Board of Education of the Worcester Central School District, upon the recommendation of the Superintendent, does hereby appoint Kimberlea Curran, who holds an Initial New York State Certificate in the School Building Leader certification area, to the full-time, twelve-month position of Secondary Principal, in the tenure area of Administrator, effective August 11, 2016, with a four (4) year probationary period and approve the employment contract agreement for Kimberlea Curran, as Secondary Principal, as presented, effective August 11, 2016. The salary and benefits for the 2016-2017 school year will be pro-rated to the effective date, August 11, 2016.
  - B. Physical Education/Health Teacher Appointment  
Upon the recommendation of the Superintendent, Alexandra Swing, who holds a Conditional Initial New York State Teaching Certificate permitting her to teach in the Physical Education certification area in the public schools of New York State, is hereby appointed to the position of Physical Education/Health Teacher in the Physical Education tenure area for a probationary period of four (4) years, to commence on September 1, 2016 and to end on September 1, 2020. The salary during the first year of this appointment will be paid in accordance with the salary schedule as outlined in the collective bargaining agreement between Worcester Teachers' Association and the Board of Education and the salary will be based upon Step 2 (\$37,060) and will include credit for graduate hours for a total salary of \$38,206 for the 2016-2017 school year.
  - C. Food Service Helper Appointment  
RESOLVED, that the Board of Education of the Worcester Central School District, upon the recommendation of the Superintendent, does hereby appoint Elaine Eager to the position of Food Service Helper, with a 52-week probationary appointment, to be paid at Step 5 as per the WNTP contract, effective September 1, 2016.

E. School Guidance Counselor Appointment

RESOLVED, that the Board of Education of the Worcester Central School District, upon the recommendation of the Superintendent, does hereby appoint Poletta Louis, who holds a permanent New York State Teaching Certificate permitting her to teach in the School Counselor area in the public schools of New York State, to the position of School Guidance Counselor in the special subject area School Counseling and Guidance tenure area for a probationary period of four (4) years, to commence on August 15, 2016 and to end on August 15, 2020. The salary during the first year of this appointment will be paid in accordance with the salary schedule as outlined in the collective bargaining agreement between the Worcester Teachers Association and the Board of Education and the salary will be based upon Step 1 (\$36,698) and will include credit for a masters degree and graduate hours for a total salary of \$40,048 for 2016-2017 school year.
