Mr. Gonzales reported to the Board that things at SED have changed, WCS went from a 20-week review to a 26-week review for comments. BCA is still prepared to expedite responses within a day or two. John Sokol has offered a possible solution which is to use a Co-op that has been approved by the comptroller as of 2018 as a means to secure contractors. Met with Smith Site Group who assist in cooperative contractors. They secure and lock in pricing of contractors who have already been vetted and gone through the procurement process. If we decide to sign a contract with them, we then forgo the procurement/bid process and expedite it to building. They can assist in the long lead items now.

WHEREAS, the Board of Education received proposals from potential purchasers of the Property that complied with the published Request for Proposals, previously authorized by Resolution of the Board of Education;

WHEREAS, after reviewing the merits of each proposal, following the criteria set forth in the Request for Proposal, and considering the Board's fiduciary duty to obtain the best possible price for the Property, the offer to purchase the Property submitted by Stewart's Shops Corp. is the best offer available; and

NOW, THEREFORE, be it resolved as follows:

- 1. The Board of Education of the Worcester Central School District hereby selects the proposal by Stewart's Shops Corp. for the sale of the Property for a Purchase Price of Fifteen Thousand Dollars (\$15,000.00), which is in the in the best interest of the District.
- 2. The transfer of the property is an Unlisted Action under SEQRA and upon review it is determined to not have an adverse environmental impact.
- 3. The Real Estate Purchase and Sale Contract is approved.
- 4. The officers and employees of the District are authorized and directed to take all steps necessary or appropriate to complete the transaction.
- 5. This resolution shall take effect immediately.
